

#### **SOCIUS PRIVACY POLICY**

[Last Updated: 25 July 2019]

This Privacy Policy (referred to herein as "Policy") describes how Socius Holdings (Pty) Ltd. (referred to herein as "Socius", "we", "us", or "our"), collects, uses, discloses, and protects the personal data we may hold about you, your employees, or agents; electronically or otherwise. This Policy applies to all clients of and recipients of information provided by Socius.

As the data controller of your personal data, we control how all personal information we are holding about you is stored, processed, or transferred. We will only deal with your personal data in accordance with the terms of this Policy. By using our website, you consent to this policy. For information on how we handle client data please consult the Socius Data Protection Policy.

# **Collecting & Using Information**

We collect personal data if you submit it voluntarily or we otherwise learn it through our interactions with you, which may include your name, email address, and contact details. We continuously review our records to ensure your data is as accurate as possible. We may therefore consult alternative sources in order to do so, such as company websites and other publicly available sources.

Socius collects and uses information that it believes to be factually correct, relevant to its work, and not excessive. We are always respectful of our constituents in regards to information retained. We do not store any sensitive information such as such as race, religion, political affiliation, or sexual orientation without your explicit consent.

The information we collect may be used by us to communicate with you for marketing, promotional, and administration purposes in connection with our legitimate business interests. These communications may include:

- Advertising and promotion of Socius events and services;
- Distribution of Socius mailings (e.g. webinars, sector news, and reports); and
- Eliciting non-financial support (e.g. support with research projects, advice on recruitment, and participation in benchmarking).

### Disclosure of Information to Third Parties

Socius generally does not collect, use, or disclose personal data to any third party or for any other purpose that is materially different from the purpose we originally collected it for or to which you consented.

However, Socius may share your data:

- In the event that Socius is bought by a third party data held about our customers will be one of the assets to transfer to the buyer;
- To protect our interests, rights, and property in the event of a claim or dispute brought against us; or
- If we are required by applicable law, regulation, operating agreement, legal process, or in response to valid requests by law enforcement officials, governmental agencies, or other public authorities, including to meet national security requirements.

In the event your personal data is to be disclosed to a third party or used for a purpose that is materially different from the purpose we originally collected it for or that you consented to, we



will notify you to seek your consent to the sharing and offer you the choice to opt out of such collection, use, or disclosure. Any such transfer will only be on terms that the confidentiality of your personal data is protected and that the terms of this privacy policy will continue to be complied with by the recipient. #### Use of Cookies

As is standard practise, we use cookies to improve your browsing experience, keep our website running optimally, and help maintain the security of our website.

Unless you as a visitor knowingly supply the information, cookies generally do not contain any personal data.
